PLEASE READ AND SIGN BELOW:

! THIS IS NOT A CLOSED COURSE. THERE WILL BE TRAFFIC ON THE ROADS, THEREBY INCREASING POTENTIAL DANGER.
! THERE ARE STEEP HILLS ON THIS COURSE, THEREBY INCREASING THE THRILLS/DANGER OF THE COURSE.
! THE ROADS MAY BE IN POOR CONDITION (gravel, debris, potholes, bridge out) OR UNDER CONSTRUCTION, AND SUCH CONDITION MAY NOT BE VISIBLE TO PARTICIPANTS.
! THE COURSE MAY BE MISMARKED. YOU MAY WANT TO CONSIDER CARRYING YOUR OWN MAP.
! STAY ON THE COURSE. THE SAG WAGON/COURSE VOLUNTEERS WILL NOT BE DRIVING THROUGHOUT THE COUNTRYSIDE LOOKING FOR YOU IF YOU DECIDE TO TAKE A SHORTCUT AND/OR GET LOST.
! THERE IS NO CELL PHONE RECEPTION IN MANY AREAS OF THE COURSE. 911 MAY NOT BE IMMEDIATELY AVAILABLE.
! THERE WILL BE A SAG WAGON, BUT THE WAIT FOR IT MAY BE SIGNIFICANT (SEVERAL HOURS LONG) THUS, SAGGING AT AN AID STATION IS SUGGESTED.
! IT COULD BE BLAZING HOT. IT COULD BE FREEZING COLD. THERE COULD BE LIGHTNING OR ICE. BE PREPARED.
! THE SAG WAGON OPERATOR WILL MAKE THE FINAL DECISION AS TO WHETHER YOU NEED TO SAG. IF YOU DECIDE TO CONTINUE AGAINST THE DETERMINATION OF THE SAG DRIVER, YOU RISK BEING ON YOUR OWN WITHOUT AID STATIONS, COURSE MARKINGS OR ANY FURTHER ASSISTANCE OF THE ORGANIZERS. AID STATION VOLUNTEERS ALSO HAVE THE DISCRETION TO ADVISE YOU TO DISCONTINUE THE RIDE AND WAIT FOR THE SAG WAGON BASED ON THEIR OWN JUDGMENT.

IN CONSIDERATION of participating in any way in the SUICIDE CENTURY sponsored by Jay K. Anderson/ Anderson Specific Contracting, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Bicycling activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. I also acknowledge that the idiot(s) who organized this thing have deliberately chosen some pretty steep hills which could exacerbate some of the inherent risk. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity. I agree that my own personal judgment is required for safety in the event of inclement weather of any type (listed or not listed herein), as neither heat, nor strong wind, nor rain will bring an official halt to the event.
2. FULLY UNDERSTAND that (a) EVERYTHING RELATED TO THIS RIDE INVOLVES RISKS AND DANGERS OF SERIOUS BODILY INJURY OR ILLNESS, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in any aspect of the Activity, the condition in/upon which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES I incur as a result of my participation or that of the minor in the Activity. I also realize that a sore bottom and burning quads are very likely consequences of partaking in this event.
3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE, the organizer of the ride, family members, volunteers, and employees, other participants, any outside sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I, or anyone on my behalf, makes a claim against any of the Releasees, I INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damages, or costs which any may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
